### **Contest, Rules:**

#### **How to enter**

1. To be eligible for this contest, you simply have to thoroughly fill out the entry form posted on the Tourism Eastern Townships website at [www.easterntownships.org](http://www.easterntownships.org) .
2. Participants are entitled to enter the contest effective December 9<sup>th</sup>, 2006. The deadline for entries is February 1<sup>st</sup>, 2007, 11:59 p.m.

#### **Draw**

3. The random draw and winner selection will be performed on February 2<sup>nd</sup>, 2007, 9h00 a.m., at the administrative office of Tourism Eastern Townships, 20 Don Bosco Street south, Sherbrooke, Québec J1L 1W4, among all eligible ballots filled out on the Tourism Eastern Townships Web site by February 1<sup>st</sup>, 2007, 11:59 p.m.
4. In the subscription form, the participant will be asked a question which is: What's the complete name of the Hovey Manor Executive Chef? The individual on the winning ballot shall be notified by a phone call or email by before February 3<sup>rd</sup>, 2007. The winner shall receive a gift certificate confirming the prize by mail. Then he will need to contact the participating establishment directly to reserve his package offered on the gift certificate.

## **The prize**

### 5. Prize:

**Enter the contest and become eligible for a chance to win a stay of an \$800 value, at the Hovey Manor in the Eastern Townships!**
